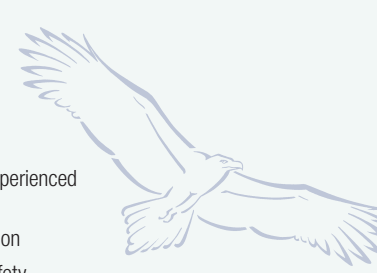

Woody weed mechanical removal

Integrated weed management

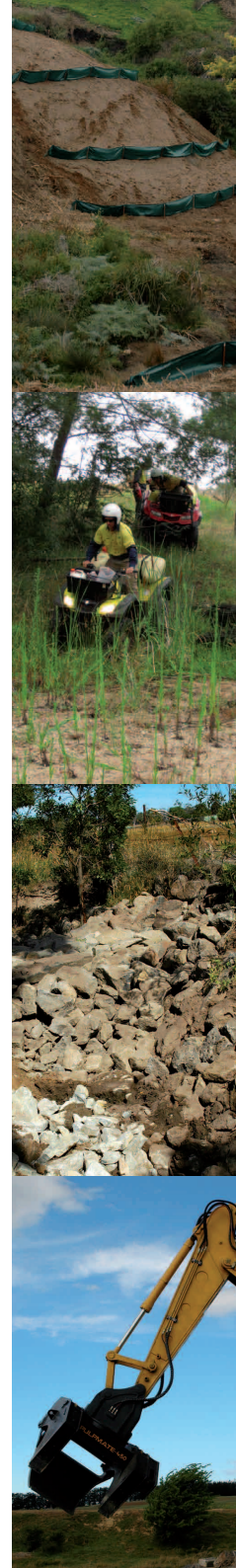

Native vegetation rehabilitation and restoration

This includes advice on species selection using Ecological Vegetation Classes, sourcing provenance seed and tube stock, seed collection, site preparation and planting or seeding of the site using the appropriate techniques. We can provide advice and ongoing services for long term maintenance and success of the site.

Restoration monitoring and evaluation

Anglopac Environmental can provide a Monitoring and Evaluation program for your site to ensure better survival and long term management. 'Landscape Function Analysis' (LFA) is a technique that assesses the soil surface condition at the time of planting which can then be evaluated over time for improvements in Stability, Infiltration and Nutrient Cycling. Other methods can include fixed photo point surveys, survival rate and species diversity surveys.
